24. Former Auction Yard, Station Road

Further to Mr Finney's presentation to the Parish Council at the last Parish Meeting, he has sent in draft preliminary drawings. The proposed scheme mix is for 13 houses, 2 Bungalows and 4 Flats with a mixture of affordable rental and shared ownership. We have been advised today by Mr Adrian Regan (Group Head of Development Shropshire Housing) that Shropshire Housing are looking to submit a Planning Application in September. Shropshire Housing is keen to work closely with the Parish Council and have suggested both a Public Consultation Meeting and a Meeting with Parish Council to progress the application. Following a discussion the Councillors agreed that a Public Consultation Meeting should be held first, this meeting to be run by Shropshire Housing with Parish Councillors in attendance to pick up observations and feedback from the general public. To allow for holiday commitments and availability of the Lyon Hall - Friday 14th September is the preferred date. The Scheme would then be discussed at the next Parish Council Meeting (20th September) when the Parish Council comments would be formulated taking into account views received from the Public Meeting. The Clerk was asked to liaise with Shropshire Housing Group make the arrangements.

26. Former Goods Yard, Station Road

Councillor Trevor has received many telephone calls and visits from Parishioners regarding this site. It would appear that Mr Stevens and his family have left the site for the summer and have been replaced by the Price family who have 9 children. Planning conditions allowed for 'vistors' to the site but as the Price children have now enrolled in the local school – this would seem to be more than just a visit.

The Utility Block has yet to be built and mains electricity has yet to be connected

Piles of rubbish have been left outside the Council bins overflowing and several black bin bags. Scavenging animals have exacerbated the problem, fortunately Refuse Collectors seem to have overlooked their normal rules and have removed all the rubbish.

The neighbouring farmer has complained about children running through his crops and Councillor Trevor has reported to the Police that dogs from the site have been worrying his sheep.

Councillor Morgan proposed that the Parish Council write to Shropshire Planning outlining these problems and requesting remedial action – seconded by Councillor Trevor all agreed.

a) Changes to Shropshire's Planning Policies

Shropshire Council has requested feedback on the operation of SPD since its adoption in March 2011. The Parish Council made the following observations

- Changes to the rules for new agricultural workers dwellings the Parish Council feel that the restriction to 100 sqm is too small
- Changes to Affordable Housing The Parish Council feels that the minimum scale for 3 bedroom affordable house should be 87sqm in line with The Greater London Authority adopted scale for a two storey house, 3 bedroom and 4 person bedspace for public and private financed homes.
