e) Street lighting – to approve routine electrical inspection and annual visual inspection of all 81 lights to build an inventory. This would allow planning for a staged conversion to LED lights which, in turn, will result in a decrease in running on-going running costs for street lighting in the parish.

i) An electrical test of street lights (20% rolling program) is due, this would be 16 lights tested at a cost of £135.00 +vat – The continuation of the rolling safety programme was approved.
ii) Annual visual inspection of all lights (81) and build inventory £486.00 +vat. To complete the 100% inspection would give the council a goal to move forward to upgrading the lighting stock. - This decision to be deferred to a future agenda.
