It was **RESOLVED** to **OBJECT** – with the comment, this is an application for a residential property in open countryside which is out of keeping with the area. The council do not consider the submitted planning statement covers the need for permanent dwelling and that a temporary dwelling (mobile home) would be quite sufficient for the need demonstrated.

- 94 **Ollerton Lodge to Peplow Chapel** – request for support from Stoke-on-Tern Parish Council.
The matter went to a vote and it was RESOLVED by a majority to reiterate their SUPPORT for the original application for a right of way and to SUPPORT the current appeal against the rejection of the 2016 application. The Clerk to write to the Planning Inspector, copied to SOT Parish Clerk.

Cllr Parker and Cllr Powell had inspected the equipment and believe they will be able to move the stop and repaint the support.
AGREED £100 expenditure limit for replacement of toddler seat. Cllr Powell to fit.
 - b) Slide and Net Rotator (Witch's Hat) - Removal of existing surfaces and replacement; Clerk to obtain further quotations. Move to future agenda.
 - c) Both swing sets - Removal of existing surfaces and replacement with turf and grass mat or, repair of wet pour. Quotations to be obtained. Move to future agenda.

- 97 **Shropshire Lieutenancy Garden Party** June 2021 nominations – close 31 March 2021
Elizabeth Downes of Peplow was nominated for her work in fund raising for chapel also, she organised a group of sewers to make 850 fabric bags for NHS workers at two local hospitals, maternity unit and four local care homes so workers didn't need to handle contaminated clothing. Their clothing was put into these bags and then, straight into a washing machine to prevent further handling.
It was RESOLVED to NOMINATE Mrs Downes.
- 98 **Hodnet Post Office** – proposal from Cllr Mackie to support if training not forthcoming. Problem has been resolved with training now organised.
- 99 **Hodnet Football Club** request for Officials' changing room facility.
It was RESOLVED to APPROVE request, subject to any necessary planning permission being sought.
Cllr Powell proposed that the Football club be advised that the football pitch should be redrawn so both ends were equal – this would allow future restoration of the path (from Station Road to the Club). Cllr Freeman to speak with the Football Club.
- 100 **Road condition and safety issues**
The Clerk had provided an update on correspondence with Shropshire Council on issues raised at previous meetings.
Cllr Nevins explained that there was a mistake on the plans for bridge repairs, showing a different bridge.
Cllr Watts reported approach from a Marchamley resident about the bends near Rookery Lane, where there is a wide verge – whether there are any plans for a footpath put from Rookery Lane to join up with the footpath at the house before the bends start.
Cllr Powell reported that previous requests for a footpath between Hodnet and Wollerton (in 1937 and 1950) had obviously not been successful. It was noted that repairs to the Rock had been requested regularly since 1951.
- 101 **Parish matters** – An opportunity for councillors to bring to the Council's attention matters of interest or concern.
Cllr Freeman – replacement of streetlights has taken place.
Cllr Parker - Station Road -two lights faulty.
Cllr Powell - Signage for new clerk's details to be added to street lights.
Cllr Parker - Christmas tree purchase had taken place (with discount). Receipt to be provided to the Clerk.
